## ENTRY TERMS & CONDITIONS

### Please note:

Any entries not received by or on the closing date (midnight on the 30<sup>th</sup> June 2025) will not be allowed. Payment of entry fee plus the event package cost per person is a mandatory payment within 10 days of the entry deadline. Any entry and event package payments not received by this date will result in the entry being cancelled.

### How to enter

Online entries can be made on the ESF Tournament Software website. The online entry system will open and accept entries from April 2025 and will close at midnight on the 30<sup>th</sup> June 2025. Only entries endorsed by ESF member nations will be accepted. Late entries will be accepted only with approval by the CAP.

### Closing date

The closing date for entries is midnight (CET time) on the 30 June 2025.

For all players, a minimum of 3 matches is guaranteed.

Please be aware, when it's not possible to play out the full schedule for draws of 96, 64, 32 and 16 players, at least the final positions 49, 33, 17 and 9 shall be played in an elimination plate.

### European Squash ID (ESID)

All players, coaches, managers and other officials must be registered with ESF. This must be approved and validated by the relevant MNF. The MNF is responsible for ensuring that all players, coaches, managers and other officials are registered with ESF prior to entry, and their entry is fully supported. ### Withdrawals

In the event of a withdrawal from the Championships, after the closing date, penalty fees additional to the entry fee will apply in accordance with Regulations Section V.

In the result of the event being cancelled due to unexpected circumstances or restrictions in place within Poland all entries will be refunded less any administrative fees incurred.

### TRANSPORT

### ELIGIBILITY

Player eligibility for the Championships is shown in Regulations - Section B2.

Players must be aged over the set age on the first day of the competition (Wednesday 27<sup>th</sup> August 2025).

#### **Categories:**

Men / Women: 35+, 40+, 45+, 50+, 55+, 60+, 65+, 70+, 75+, 80+

Players are only allowed to enter one category. A player may only play in their own age group or in the next age group younger than this. Age categories may be combined at the discretion of the Championships Director in agreement with the Event Director due to low number of entries.



## **SEEDING AND DRAWS**

The seeding and draw will be carried out by the Seeding Panel under the direction of the Event Director and in accordance with Section V4 of the Championships Regulations. Member nations have no right of appeal against seeding or draws: Regulations - Section E. The ESF Masters Sub-Committee has appointed Daniel Verhoeven as the Seeding Panel Director. The Director will nominate at least three members for the Panel at least 30 days before the start date. The Masters Sub-Committee shall approve the panel members.

The EMIC seeding Panel are responsible for seeding all entries. The role and remit of the Panel is to seed and to offer expert advice on the amalgamation of age groups, and any other relevant advice, to the Championships Director and the Event Director.

Seeding shall take into consideration: -

- a) Results of previous World Masters Championships
- b) Results of previous European Masters Championships
- c) Results of previous European Masters Circuit Tournaments
- d) Results of National Championships and National Rankings

Players will be placed in each draw using the Random Draw method as follows: Seeds 1 and 2 will be placed, thereafter players will be seeded and drawn from groups of 3/4, 5/8, 9/16 and 17/32 (or finer). Best efforts will be made to avoid players from the same Country meeting in the 1st round.

## **PRACTICE COURTS**

Practice facilities will be provided at no cost by the organiser and will be available at the venue starting the day before the Championships (Regulations – Section F6).

## **REFEREES**

Qualified referees will be provided in accordance with ESF Referee Committee procedures relating to the specific Championships and Regulations - Section F9.

## **SCORING**

PAR 11 scoring will be used (to 2 clear points).

## **SQUASH BALLS**

The Dunlop PRO XX ball will be used.

## **CHAMPIONSHIPS OFFICE**

The main Championship Office will be located within Hasta La Vista sport center.

## **RECORDING, PUBLISHING & LIVE STREAMING**

The recording of matches for coaching/performance analysis purposes is acceptable provided the player and/or their coaches do not object. The Championship will be publishing draws, results, photos of players as well as live streaming matches.



#### **DOPE TESTING**

The ESF and the hosts reserve the right to implement compulsory dope testing for any player participating in the Championships. Dope testing may be carried out in line with the doping regulations published by the WSF. Member nations are responsible for informing all their participants (including managers, coaches and physiotherapists) about the latest WSF policy on doping; and must impose the standard WSF suspension from all forms of competitive squash upon a player who has used banned substances or practices.

#### **INSURANCE AND RISKS**

Players enter and play in the Championships at their own risk. Neither the ESF, the Host Association, the Host Club nor the Organisers will accept any responsibility for injury, cancellation or other damages arising from participation in the Championships. ESF and Polish Squash Association recommends that all officials and participants have full travel -, booking cancellation -, medical - and possessions insurance when travelling to any Championships.

#### **CLOTHING AND ADVERTISING**

The ESF clothing and advertising regulations will be adhered to. In all matters of judgement or opinion arising from the interpretation of this clothing regulation, the decision of the Championships Referee shall be final (Regulations – Section P).

#### **VISA PROCEDURES**

Please note that visas may be required to enter Poland. It is the responsibility of the member nation to ensure all players and officials have the appropriate documentation and that visas are applied for in good time before the Championships.

#### **DATA PROTECTION & PRIVACY**

The EMIC team will be publishing draws, results, photos of players as well as live footage from matches, players and the venue. As this is part of the EMIC tournament rules, Polish Squash Association (PZSQ) will deem that players have accepted these regulations by entering the tournament.
